# ORDER

After arguing the matter for some time, learned counsel appearing for the petitioners rightly submits that the writ petitions may be disposed of with liberty to the petitioners to make a representation to respondent No.2-the Director of Co-operative Audit to re-consider the fee scale fixed by him relating to Audit fees payable by Co-operative Banks whose deposits are less than Rupees Twenty Five Crores. Prima facie, the submission of the counsel that the present fee scale insofar as the aforesaid class of banks are concerned is violative of Article 14 of the Constitution of India cannot be said to be without substance. Accordingly, I direct the Director of Co-operative Audit to re-consider the fee-scale in accordance with law by taking note of the facts stated in the representation that would be submitted by the petitioners within four weeks from today.
